Shannon,

It would be helpful to provide FC with the redlined version of the policy, showing the changes, as well as this explanation:

According to our Business/Auxiliary Services folks, there has been some confusion about Section II.A of University Policy 204 related to textbook and materials ordering. Apparently, some faculty members have not been submitting their book adoptions to the bookstore (which is required under the Policy) but have instead used external vendors exclusively. These faculty have advertised only outside vendors for the purchase of course materials with no mention of the campus bookstore. This has caused loss of revenue to the bookstore and University, and it also conflicts with the University's exclusive contract with Barnes & Noble.
