The Faculty Council meeting began at 1:00 P.M.

- 1. Minutes of the previous meeting of the Faculty Council. Discussion of the minutes for the March 14, 2019 meeting generated one suggestion. Ford-Eickhoff suggested, in Agenda Item #5, adding to the line, "Ford-Eickhoff suggested removing one sentence..." with the following, "because the sentence conflates the annual review process with the reappointment review process." Marks moved to approve the minutes with this amendment. Ford-Eickhoff seconded the motion. The minutes for the March 14, 2019 meeting were approved unanimously with one amendment.
- **2.** Request to award degree in memoriam to Imtiaz Ikram. Rasmussen moved to award. Marks seconded the motion. The motion to award degree in memoriam to Imtiaz Ikram was approved unanimously.
- **3. Request to award degree in memoriam to Joel Laws.** DiBiase moved to award. Rasmussen seconded the motion. The motion to award degree in memoriam to Joel Laws was approved unanimously.
- **4. Request to award degree in memoriam to Pracheta Dutta Tumpa.** Marks moved to award. Ford-Eickhoff seconded the motion. The motion to award degree in memoriam to Pracheta Dutta Tumpa was approved unanimously.
- 5. Review of the Five-Year Academic Calendar. 2022-2023 is the column we have not seen yet. Second summer start has been changed to July 5 from July 3 based on suggestion of FEC. The Registrar's Office made that change to the draft calendar, which will cause the session to end on a Thursday. This reduces the amount of time for grading by one day. Leeman believes this a fair trade off.

It was noted, the first day of class starts during the Republican National Convention being held in Charlotte. Center City building will be impacted.

Marks moved to recommend approval to the Chancellor. McCarter seconded the motion. <u>The motion to recommend approval of the Five-Year Academic Calendar to the Chancellor was approved unanimously</u>.

- **6. Request to revise Grading Policy regarding grade replacement.** The revision would like to provide automatic grade replacement for the first two courses a student takes again. Email notification with opt out option is sent to the student. The reason for the proposed change is that many students thought grade replacement was automatic or did not know the time requirement for applying for grade replacement. This will help make the process easier for students.
 - Q: Mullis asked, if passed, when this policy would begin.

A: Leeman indicated Fall 2020.

Q: Mullis asks if the first two courses you register for that are repeats will receive automatic grade replacement, how far back the policy would reach. For example, would it grade replace a grade course you took 15 years ago? The Grade Replacement Policy began in 2007. How should ITS write this?

A: Mynatt answered that if you have a degree and come back for a second degree, you can only use grade replacement for the second degree. We could keep it as 2007 and add language to the policy that this will not apply to courses taken prior to 2007.

Rasmussen concerned that this negatively affect students who took courses prior to 2007. Ford-Eickhoff made a motion to add to the policy that courses prior to 2007 do not apply. Dean Smail confirmed that the University did not have grade replacement in 2005 Catalog. The motion to amend the policy to indicate that grade replacement does not apply to courses taken prior to 2007 carried.

Q: Schmedake asked what would happen if a student registers for two courses in the same term that are repeats, but the student only has one of the two grade replacements left. Which course repeat would the grade replacement apply?

A: Leeman said it would likely be automatic for the first of the two courses the student registers for that term, even if it is first by only a few minutes.

Q: There was a question about whether the system would correctly identify when a topics course was being repeated.

A: Leeman believes it will not happen automatically for a topics course where the topic is the same.

Q: There was a question about repeating a course multiple times and ensuring the proper grade is replaced.

A: Leeman suggested voting on the policy with the understanding that the policy language may need to be fine-tuned for ITS implementation.

Rasmussen moved to approve the revisions to the Grading Policy with the one amendment. Avrin seconded the motion. The motion to approve the revisions to the Grading Policy were approved unanimously with one amendment.

7. Request to establish the Department of Writing, Rhetoric, and Digital Studies. Wickliff spoke and said the Department of English has not had a chance to review and respond to this request in its entirety. The Department of English could be affected by this and faculty would be shared. He

would like to bring his department's input back to the Faculty Council. Wickliff moved to table this agenda item until the next Faculty Council meeting. Another member seconded the motion. Dean Gutierrez stated that this request has been in the works for some time and there was consultation with CLAS Faculty Council. The motion to table the request to establish a Department of Writing, Rhetoric, and Digital Studies to the next Faculty Council meeting was approved by a vote of 25 to 14, with five abstentions.

8. Discussion Item: Draft of Revised Code of Student Academic Integrity. Leeman this agenda item is simply consultative and that James Lorello, Associate Dean of Students and Director of Student Conduct & Academic Integrity, is here to talk about this draft and receive feedback. Lorello shared that he joined UNC Charlotte in his role as Associate Dean of Students in January. This revision of the Code of Student Academic Integrity is the first project on his list. The working group including Academic Affairs, Student Affairs, the Chair of the Faculty Academic Policy and Standards Committee, and others. Our team focus was to make it simpler for students and faculty. The revisions create a facilitated resolution step. Facilitated resolution could be used when the student is not in agreement with settlement, but not keen in going before the hearing board. It is an inbetween the informal resolution and the hearing board. The revisions shortened the document a bit, and we will have an additional procedures document that will accompany this. Made language clearer. Example: if faculty member is unavailable, can have someone appear on his or her behalf.

Q: McCarter asked if this information would be online.

A: Yes, once approved.

9. Discussion Item: Faculty Roles and Responsibilities. The

Q: Dean Johnson had a question about the 'request for accommodation'. Whom do you submit it to and who approves it?

A: Lorden said the discussion was that this would be the department chair.

Johnson suggested we make it clear that it is the department chair.

Q: Rasmussen asked if this is not a policy, what it is.

A: Lorden said they are guidelines created largely to provide guidance about what is expected.

10. Report of the Chancellor. Chancellor Dubois shared the following:

- Birth announcement of his twin grandsons.
- University IT assessment Please file your final comments and concerns. Final set of decisions will be made in the Fall after looking over assessment this Summer.

- Hotel conference center financing concluding. There will be construction traffic. We will be adding a construction road that will convert into another exit. This exit will not be affected by light rail crossing.
- Medical school situation update we have studied having a medical school for 2.5 years.
 We have understood from the beginning that Atrium Health had no interest to subsidize. A look at the numbers shows it is a non-starter. We will look at it again, if developments arise and/or situation changes.

11. Report of the Provost. Provost Lorden shared the following:

- Starting next Spring, faculty will be required to enter the last day of attendance for students failing course.
- We have sent out a financial aid message regarding how we are now operating under provisional certification by the U.S. Department of Education (DOE). Every five years we have to re-certify to offer federal financial aid. We failed to identify some off-campus sites that we were using. In the short run, anything not approved by February 28, 2019, has to be approved by DOE. This will likely add about 90 days to approval process. When adding a new program, you will need to understand this delay will occur. New programs, certificates, new sites, all need approval. Please direct your questions to Leslie Zenk, Assistant Provost.
- Emeritus policy reminder Note that we previously amended the emeritus policy, so that faculty that are non-tenure track can be nominated and honored with emeritus status. Emeritus status comes with free parking. Please nominate those you believe deserve this honor.
- The Teaching Excellence Awards Committee has completed its work and there are three finalists for the Bank of America Award for Teaching Excellence and three finalists for the UNC Charlotte Award for Teaching Excellence (for non-tenure track). These awards will be awarded on September 6.
- Facilities will need to shut down some buildings to do some extensive electrical work. This will be done one building at a time. Some academic buildings will be affected. We will have a list, so you can prepare for this. Accommodations will be made. Communications will be sent to the campus detailing these accommodations.
- Let us talk about how we onboard students in this University. SOAR sessions and Prospect for Success have great attendance. We have gathered a lot of information. We want input from the faculty about the general notion of how can we deliver important information to students timely so they get it when best needed. A more systematic and better-integrated system of onboarding our students is what we need and faculty can help.
- Thank you to Richard Leeman for your outstanding job as Faculty President.
- **12. Report of the President-Elect.** Avrin said he has only one item to report the wonderful job Richard Leeman has done as Faculty President. Leeman is the first Faculty President to serve a 2-year term and has had numerous achievements; too many to list. Avrin presented Leeman with a plaque honoring his service.

13. Report of the President. Leeman shared:

- The Non-Tenure Track Review, Reappointment and Promotion Procedures proposal and the Review of Teaching Personnel Guidelines proposal were two items that we did not have enough time to get through FEC. This will be on the agenda in Fall.
- I informed the Board of Trustees that we are fortunate to have a very collaborative style of leadership initiated by both our Chancellor and Provost. They have gone more than an extra mile to help with the things I have brought to their attention.
- Leeman ceremoniously passed the President of the Faculty gavel to Joel Avrin.
