- 1. Minutes of the previous meeting of the Faculty Council. Discussion of the minutes for the February 16, 2017 meeting generated no comments. Leak moved to approve. The February 16, 2017 minutes were approved unanimously.
- 2. Request to change the name of Ph.D. in Geography and Urban Regional Analysis. Dean Reynolds informed the Faculty Council that this request has not consulted the Graduate Council. Reynolds moved to table until after the request has been through the Graduate Council. Hopper seconded the motion. The motion to table was approved.
- **3.** Motion to Award Degrees Spring 2017. This comes as a motion from the FEC. The motion was approved unanimously.
- **4. Report of the Chancellor.** The Chancellor could not attend. Chief of Staff Kim Bradley made a couple remarks on his behalf.
 - There is a delay in the opening of the light rail extension. The projected target for completion is now March 2018. Discussions with CATS indicate it might open before then. In May we will have a better idea of when the opening of the light rail extension stands.
 - Update on diversity initiatives we will let the Provost speak on this.
- 5. **Report of the Provost.** Update on the following items coming up between now and the next meeting:
 - On April 6th, there is a session on creating an inclusive classroom. The lecture is in McKnight Hall. Spread the word. Garvey Pyke and the CTL are supporting this.
 - Summer Diversity Institute news of this will be coming.
 - Students from Shanxi University, an international partner institute of ours, will be putting on a dance and musical performance in McKnight Hall on March 29th. I encourage our students to attend.
 - On April 12th Roland Fryer, Professor of Economics at Harvard University and Behavioral Economist, Activist, and Author, will present a lecture on "The Economics of Race".
 - We are working on creating a one-stop shop for student services, called 'Niner Central'. This will involve having people cross-trained to provide a series of student services. The location will be where the candy counter is in Cone. We are hoping to have this up and running by November.
 - Establishing a transfer center. The Freshman population is stabilizing well; however, the transfer population continues to be very large. We will continue to see many transfer students coming to our institution. We need to help them even before they come here to help with a smooth handoff to the departments.

- Council in Community Working Group is a working group for implementation of the campus diversity plan. We want to increase visibility of the work going on in the colleges and other units to increase diversity and inclusion. We need to share information about what is happening in the colleges, work more collaboratively across the colleges, and share best practices. We are looking for someone to chair this working group amongst the faculty ranks on a half-time appointment for 2-year term.
- Funding for graduate students Dean Reynolds is about to commission a group to talk about this.

Reynolds shared: The task force in 2004 put together a report on all aspects of funding for graduate students. We have grown and things have changed. It is time to get together a group to help us look at the basics of a strategic plan. We need to revisit. I am hoping to get started soon and have report by end of Fall.

• A year ago, the Chancellor signed the campus agreement to design a civil action plan. The time has come to develop the plan. There is a planning group led by three people. A large group on campus is working to develop this civic action plan.

Q: Transfer students usually have different problems than freshman students. Do we have a plan for them?

A: Yes, we will. More targeted advising. Looking at advising and how we can do it better.

- 6. Report of the President-Elect. Leeman shared the following:
 - Showed the Council a list of open faculty governance positions that are up for universitywide election. Asked the room to help him recruit. The deadline is being extended a few weeks.
 - Faculty Assembly put together a technology task force at the UNC System level. They are trying to do something more organized and strategic than 'University Online'. President Spellings says we want to serve the natural students in our system and are not trying to be the University of Phoenix. Leeman asks the Council to keep an eye out for requests for proposals, especially those of you involved with technology, online, and distance education.
 - Reminder that with the strategic plan, the most immediate item of need is to state what areas of distinction our campus has. The Chancellor is working on that and hopefully we will have discussions on that between now and May.

Lorden added that they are piloting a half-semester course. CHHS has volunteered to be a pilot on that for a couple of their courses.

Lorden said the areas of distinction are going to be required to have external benchmarks. So we need to make a case of specific areas of expertise – and will need to be asking you all what kinds of measurements/markers are relevant so we can meet the goals of this initiative.

7. Report of the President. Walker has no report today.

8. New Business.

Risley – The Department of Chemistry believes the change to the procedures for withdrawal for extenuating circumstances needs to come to Faculty Council, as it was a policy change not just a procedural change.

Walker said we will discuss this at our next meeting. Thanks.

Gossett – working on a task force working on course evaluations. Looking at the course evaluation process, response rate, how they are used by faculty. Gossett asked the room: How are we evaluating teaching in general? How all the evaluations fit together and work together? What strategies do you use to promote evaluations? Do you, the departments, use?

A: We inform our class that if the response rate is 95% or greater the whole class gets extra credit. Then we monitor the response rate during the semester.

Gossett - Do you tell them to fill them out? Do you remind them? Do you tell them what we use it for? I find that telling students that you will use these to change the assignments empowers them and results in better quality evaluations with more specific information given by students.

A: Our department chair sends a reminder to complete them.

Gossett - Do your departments talk about course evaluations?

A: Yes, our department had a low response rate, so we had a meeting about increasing our response rate.

Gossett - As we develop student evaluations, we need to understand the impact on female and nonwhite faculty and think about an approach that will reduce the amount of bias.

A: Give students time in class. Students do not want it to take away their time. Paper was around a 70-80% response rate, with current online format the response rate is now 46%. This is the captive audience effect. If we give our students time in class to complete the evaluations the response rate should increase.
