The Faculty Council meeting was called to order at 1:01 P.M.

- Minutes of the previous meeting of the Faculty Council. Discussion of the minutes for the September 27, 2018 meeting generated no comments. Marks made a motion to approve and McCarter seconded the motion. <u>The minutes for the September 27, 2018 meeting were approved</u> <u>unanimously.</u>
- 2. Revision to the Constitution of the Faculty regarding Secretary of the Faculty position. Leeman gave background on the proposed revision. We are not voting to approve, we are voting whether to put it up for vote by the full faculty body. Reasoning for changes to Article IV – Now that the Secretary does not have to take the minutes (they still supervise the minutes), the Secretary is underutilized. They can promote communication between the faculty council and the departments. There may be times an email should go out to the Faculty Council, newsletters, etc. Last year we did not have a President-Elect or a Past President (as she took an administrative position), so it would be useful for the other Officer of the Faculty, the Secretary, to be able to fill-in. Reasoning for changes to Article VI – This is the only position on the Faculty Executive Committee that is a oneyear position. All other FEC members have two-year positions. A person working to promote communication should serve longer than one year, much like we moved President to a two-year term recently. Comments? Questions? Hearing none do I hear a motion? Marks made a motion to advance the proposed revisions to the *Constitution of the Faculty* to a vote by the full faculty body. D'Amico seconded the motion. Godev notes a typo. Leeman said the FEC saw the typo as well and we should have sent to the Faculty Council the corrected version approved by the FEC. Marks made a motion to advance the proposed revisions, with typo correction, to the *Constitution of the Faculty* to a vote by the full faculty body. Paddock seconded the motion. The request to advance the proposed revisions to the Constitution of the Faculty for a vote by the Faculty was approved unanimously.
- 3. Request to revise Posthumous Degree Policy (endorsed by FAPSC on 9/18/18). The main revision to this policy is to add a "degree in memoriam". To qualify for a posthumous degree the student needs to be well on their way to graduation. Some families would like some recognition even when the student does not qualify for a posthumous degree. This policy change could help. It is not technically a degree, so it does not have to meet the requirements of a degree as qualified by the UNC System. I am not sure how many students will qualify for this each year. We have been asked to waive the policy in the past and that is tough. Degrees in memoriam is not unusual; this is a growing trend. The University of Florida has a very similar acknowledgment. For degrees in memoriam, a diploma will not be issued (perhaps a certificate) and will not be part of the commencement ceremony (perhaps a separate ceremony). I am unsure exactly how the ceremony for this will be arranged, but I think there is an intention to offer some kind of ceremony if requested. The policy has the department make the request to issue this degree in memoriam, similar to the posthumous degree. Shaikh made a motion to approve the revisions to the Posthumous Degree Policy. Marks seconded the motion. The request to revise the Posthumous Degree Policy was approved unanimously.

4. Graduate Student Funding Task Force Report. Johnna Watson gave a presentation on the preliminary findings and recommendations in the Graduate Student Funding Task Force Report. The final report is not out yet, only the preliminary findings and recommendations. The Task Force was put together by Dean of the Graduate School Tom Reynolds. Watson displayed the composition of the task force and a view of their efforts. The Task Force continues to meet to finalize the report. Models on how to support students differ greatly across different universities and programs. Watson provided findings on Graduate Assistant (GA) stipends. Our graduate assistantships are below the national average making it hard to attract and retain quality graduate students. Watson shared an email of a doctoral student to form a picture of what our University is dealing with. The email said the student was willing to transfer to afford dental care, as the transfer institution will help with that. Watson also showed GAs by source and showed level of funding and where it comes from. In the College of Liberal Arts & Sciences only one program paid a stipend above a living wage (a nice graphic put together by Richard Tankersley). From an annual survey of 50 schools, UNC Charlotte comes in around 44 and 48 of 50 schools. GASP funds have not increased proportionally with increases in graduate tuition and enrollment. The support of international students way exceeds the support for domestic students. \$3300 per year in fees for domestic students and \$3500 for international and that is just fees. Enrollment numbers of out-of-state students dropped in 2017-2018 and this was a result of us pushing them to become residents after 12 months. Average debt amount was \$80,000 for doctoral students who borrowed federal monies. International students can take out private loans and use credit cards. One recommendation is to create a Graduate Council sub-committee on Graduate Student Funding and Fellowships. Recommendation #2 involves building a sustainable graduate assistantship model. A third set of recommendations involves providing a scalable tuition model. Watson fielded questions.

Q: Phillips mentioned that the graph showed \$17-18 million spent last year and asked how much would the cost be for \$18,000 each graduate assistantship plus health insurance.

A: Watson said we would need to know the number of assistantships we will have. It seems many have numerous assistantships, but they are all underfunded. Would it be better to have less and fund them better?

Q: How soon will these types of recommendations come to fruition?

A: Reynolds answered perhaps by next budget cycle. There will need to be time for colleges and units to plan. This will not be something that will be ready by next Fall.

Q: Dean Johnson says our TAs on average grade for 100 students. When I talk with deans of other universities they are shocked. We cannot have less or the workload would be way too much.

A: Watson offered that we may need a subcommittee task force to look into workload policy. Leeman mentioned that the Task Force did not look into that as we had enough of a charge looking at funding, but this could be something that should be looked into – this variability of workloads depending on your department. What is the fair work to be expected for 20 hours a week?

- **5. Report of the President-Elect.** President-Elect Joel Avrin informed that the Faculty Assembly had a meeting last week and provided the highlights of what he observed:
  - Chancellor searches There was controversy in how the search at Western Carolina was being torpedoed. A member of the Board of Governors was interested in the position. They did come up with a new policy meant to address the conflict of interest. The Board of Governors want to keep the searches as confidential as possible with the idea that some candidates are interested but already have positions and do not want anyone to know they are actively looking around. Faculty Assembly wants it as open as possible and allow as much faculty and student input as possible. They are talking about select faculty having a role with the top three candidates. Still an ongoing conversation.
  - Priorities of the Board of Governors Chair The Chair of the Board of Governors spoke at the Faculty Assembly meeting. He mentioned lots of unused buildings and wants to know why we cannot repair these buildings. He is a business man and seemed big on efficiency.
  - Priorities of the faculty salary and retirement. The Board of Governors are looking around the country to see if people are leaving for not being compensated reasonably. They will respond to data. Avrin believes we should be able to highlight our star performers differently than other faculty.
  - Summer school The Board of Governors wants to expand what we do in summer school. They want to make it more attractive for faculty to teach in the summer.
  - Employment assistance program A presentation was made on the employment assistance program. The program provides emotional support. They have work-life solutions. They can recommend contractors and event planning, legal guidance referrals, financial counseling, etc.
  - I volunteered for the free speech subcommittee. They do not want us to prevent provocative speakers from speaking. At present, they are leaving it up to us to police the policy. Each campus has responsible free speech officers.
- 6. **Report of the President.** President Richard Leeman provided his report to the Faculty Council. You may notice that we are not tackling online course assessment and certification today. The Faculty Executive Committee is compiling pros and cons of both approaches. This will likely be an agenda item on the November agenda of the Faculty Council.
- 7. New Business. None.
