Make the following revision the Graduate Catalog:

- Add the word "degree" in front of program in the 1st sentence
- Remove "degree" in the 2nd sentence
- Graduate School Dean will update documentation and communicate with Faculty Council.
- Dean Reynolds will discuss endorsement and share at the April 5th meeting.
