II. Report of the Graduate School Dean – Johnna Watson for Dean Reynolds

- Watson recognized Janet Morse, Graduate School, to report on fall graduation stats:
 - o 57 doctoral students
 - o 508 Master's
 - o <u>269</u> Certificates

This number is slightly higher than fall 2020 (810).

- Watson reported on Spring 2022 enrollment numbers
 - o New enrollment numbers are down 125 students as compared to 2021.
 - o One of the largest programs, Certificate in Teaching is seeing some volatility due to legislative changes and attrition in the school systems.
 - o Overall, our graduate numbers are good, but fall 2022 will be a challenge to meet our goal because of a large number of students who will be graduating.
 - o Doctoral research numbers are still strong.

Krause asked the Council at the December 7, 2021 meeting to take this proposal back to their programs/colleges for feedback. This proposal sets a benchmark for programs to follow but all programs can set more strict guidelines if appropriate.

Lachance made a motion to approve the proposal with a second from Morse. The motion was approved by a unanimous vote.

B. Continuous Registration/Leave of Absence –

Sandy Krause and Katherine Hall-Hertel, Graduate School

The Graduate Policy Equity Working Group is looking at graduate policies with an unbiased lens.

- University policy states that after 12 months of no activity, a student becomes inactivated.
- There are challenges to the current policies and more clarification is needed for continuous registration/leave of absence.
 - Need clarification and guidelines for 7800/9800 courses and progress toward degree completion.
 - SEVIS Immigration status new students must be enrolled to get access to library and other systems.
 - Summer enrollment status is challenging. Students must be enrolled if applying to graduate. If first semester students are in "leave of absence", then second semester the students is made inactive.
 - o Students in GASP do not have funding during the summer.
 - Need clarification of "in person" for electronic access.
 - When students are on leave, they are treated like any member of the community as we are state supported school.

The Council discussed this proposal at large and decided to hold off on taking a vote for more clarification on a few items. Will revisit this topic at a future meeting.

V. Other Business

Brintnall asked that the Council review the Graduate Course Syllabus Guidelines (Checklist) document for the most current version. Chair Dalton communicated that this will be added to the March 1, 2022 agenda.
