**ARCH 7102. Topical Design Studio. (5)** Prerequisite: ARCH 7101. This design studio focuses on issues relevant to current architectural practice and/or exploration of architectural theory. Students choose from among several sections of this studio, each of which addresses a different set of issues. The issues addressed as well as the pedagogical approach of these studios are defined by the faculty teaching them. All students must take a minimum of one Topical Design Studio within their area of Concentration. [Course may be repeated with permission.](#) *(Spring)*

**ARCH 7103. Topical Design Studio. (5)** Prerequisite: ARCH 7102. This design studio focuses on issues relevant to current architectural practice and/or exploration of architectural theory. II students are also required to take one of these courses (3 credit hours.) Architecture graduate students may take additional architectural history electives as desired. **May be repeated for credit as topics of course change.** *(Fall)*
