I. Approval for the March 12, 2013 Meeting Minutes

There being no further discussion, the motion was made to approve the minutes pending the one revision. The motion was made by Swayne with a second from Anderson. The motion was approved unanimously.

II. Report of the Chair

- Chair McGregor commended the GPSG for their hard work for the Graduate Research Symposium. Sarah Birdsong and Liz Shockey did a great job; it was well organized.
- Announced that Sarah Birdsong, Graduate Council Student Rep was defending on Thursday, April 4, 2013.

III. Report of the Dean

IV. Graduate Course and Curriculum Proposals

A. <u>ECON 11-30-12</u>: Replacing Current Concentrations in the MS Econ Degree with Options that currently exist.

Chair McGregor called for a motion to consider. Swayne made the motion with a second from Birdsong. There being no further discussion, Chair McGregor called for a motion to approve as submitted. The motion was made by Davis with a second from Anderson. The motion was approved unanimously.

B. ENGL 11-27-2012: Effective Grant Writing

Chair McGregor called for a motion to consider. Davis made the motion with a second from Smith. Two revisions were noted:

- The pre-requisite for the proposed course should be included in the catalog copy.
- The syllabus should include the A-B-C-U graduate grading scale.

There being no further discussion, the Chair called for a motion to approve pending these two revisions. The motion was made by Anderson with a second from Davis. The motion was approved unanimously.

C. GEOG 01-15-13: Coupled Human and Natural Systems

Chair McGregor called for a motion to consider. Birdsong made the motion with a second from Swayne. A discussion ensued and the following revisions are requested:

- The courses being created are GEOG 6620/8620, ESCI 6620, and INES 8620, so references to GEOG/ESCI/INES 6000/8000 need to be corrected
- The syllabus says nothing about which students are evaluated.
- The syllabus needs to include the A-B-C-U graduate grading scale.

There being no further discussion, the Chair called for a motion to approve pending these revisions. The motion was made by Swayne with a second from Anderson. The motion was approved unanimously.

- D. MBA 10-24-12: Establishment of a New MBA Course "Advanced Business Analytics Chair McGregor called for a motion to consider. Davis made the motion with a second from Birdsong. There being no further discussion, Chair McGregor called for a motion to approve as submitted. The motion was made by Swayne with a second from Anderson. The motion was approved unanimously.
- E. MBA 3-14-13a: Establishment of a New Graduate Course MBAD 6276 Consumer Analytics Chair McGregor called for a motion to consider. Swayne made the motion with a second from Anderson. There being no further discussion, Chair McGregor called for a motion to approve as submitted. The motion was made by Davis with a second from Birdsong. The motion was approved unanimously.
- F. MBA 3-14-13b: Establishment of a new MBA Concentration in Quantitative Methods for Business

Chair McGregor called for a motion to consider. Davis made the motion with a second from Anderson. There being no further discussion, Chair McGregor called for a motion to approve as submitted. The motion was made by Davis with a second from Swayne. The motion was approved unanimously.

G. MBA 3-14-13c: Elimination of Sports Marketing and Management Concentration in the MBA Program

Chair McGregor called for a motion to consider. Lipford made the motion with a second from Anderson. There being no further discussion, Chair McGregor called for a motion to approve as submitted. The motion was made by Smith with a second from Lee. The motion was approved unanimously.

H. MSW 3-6-2013: Updates to the Master of Social Work

Chair McGregor called for a motion to consider. Davis made the motion with a second from Anderson. Chair McGregor commented that even though the proposal was submitted as a short form, it has components of both short and long form. The Chair also commented that the information submitted appears to be in order but would call for a motion for this to be approved but move forward on the Consent Calendar process. The motion was made by Davis with a second from Anderson. The motion was approved unanimously.

V. <u>Graduate Program Review Draft Reports</u>

A discussion took place. Gray suggested that the committees replace the term "Recommendations" on the report to "Suggestions" and the Graduate School Dean can determine what rises to the level of a recommendation to the program.

Chair McGregor called for the reports by noon on April 16.

Dean Reynolds communicated that the Chemistry department review be deferred to next year.

VI. Other Business

- Davis suggested that for the Graduate Teaching Award, the award be divided between Master's and PhD.
- The question was raised about whether GASP covers a program tuition surcharge. The answer was that it does not; students have to cover tuition surcharges as well as fees as out-of-pocket expenses.
