19 proposals were on the consent calendar that members commented were ready to be approved. 2 proposals had easy fixes. READ 6248 needed to have the course number added, which Secretary Jones already did, and BDBA 8211, which needed easy fixes that Chair Brown was able to complete. Walter motioned to approve both proposals, and Lipford seconded the motion. The motion was approved unanimously.

Lipford made a motion to accept the proposals on the consent calendar and Ivey seconded. The motion passed unanimously.

Gall had commented on BDBA 8141 that the librarian comments were missing. Lipford motioned to accept the proposal as is. Gall seconded the motion. The motion passed unanimously.

BDBA 8231 had several comments. Secretary Jones made some changes during the meeting with permission of the department members attending. Ethan Chiang will reach out to faculty members in the department to get clarification on the pre-requisite. Bin Abdul Baten motioned to approve the proposal pending the clarification from the program. Lipford seconded the motion. The motion passed unanimously.

Lipford had questions about the timeline for BDBA 8201. The department attendees confirmed that the timeline is correct because the course is only offered on weekends. They also confirmed that the course does not have prerequisites.

BDBA 8241 also did not have the librarian section checked. Lipford motioned to approve the proposal as is. Gall seconded the motion. The motion passed unanimously.

Cox made a motion to approve EDCI 8122 and 8136 as is. Lipford seconded the motion. The motion passed unanimously.

Xu had questions regarding EDCI 8030's effect on other programs and courses. The attendees from the College of Education confirmed that there is no effect on other programs. Lipford motioned to pass the proposal as is, and Cox seconded the motion. The motion passed unanimously.

Walter made a motion to approve the IT IS course proposals as is. Bin Abdul Baten seconded the motion and the motion passed unanimously.

Chair Brown recommended sending the ACCT proposals back to the originators. Walter motioned to approve the ACCT proposals pending the corrections from the originators. Gall seconded the motion and the motion passed unanimously.
